BY-LAWS OF THE LAKE SHORE H.O.G. CHAPTER

- 1. The Lake Shore Chapter of the Harley Owners Group Shall Follow the "Constitution for Local Chapters Affiliated with the Harley Owners Group" Published By The Parent Organization.
- 2. The Officers and Appointment Thereof Are As Follows:
 - **A.** In exercising the provisions in Article III of the "Constitution for local Chapters affiliated with the Harley Owners Group" and approval of the National Offices of the Harley Owners Group; The Sponsoring Dealer Chooses to hold annual elections for Chapter Officers and Directors to administer the Business Functions and act as the Governing Body of the Lake Shore Chapter.

B. Composition

1. Sponsoring Dealer

The Sponsoring Dealer may assume any or all Officer Positions including their respective responsibilities.

2. Chapter Officers and Board Members

The Sponsoring Dealer shall hold elections or approve Five (5) members to serve as Officers and Directors of the Chapter. These five Director/Officer positions shall consist of **Director**, **Assistant Director**, **Treasurer**, **Secretary and Chapter Manager (an employee of the dealership).** Other discretionary Officers may be appointed as needed, however only those Officers aforementioned will also serve as Chapter Directors. The Board of Directors shall be responsible for guiding the activities of the Chapter in order to maintain the purpose of a Local Chapter as intended by The Preamble of the National HOG Constitution. The Board of Directors shall meet at least once each month with the Sponsoring Dealer or his designated representative. Elected Officers and Secondary Officers must own a Harley-Davidson motorcycle. Road Captain's must own and RIDE a Harley-Davidson, when leading and sweeping chapter rides.

C. Approval

The Chapter Sponsoring Dealer shall reserve the right of approval of all Directors and Officers and shall have the right of Dismissal upon written notification of The Board of Directors.

- **3.** Dues for the Lake Shore Chapter shall be Twenty Four dollars (\$24.00) per year. Membership renewal shall be due as of the published January sign-up date for each year. All previous year Memberships shall expire as of the January sign-up date.
- 4. Lake Shore Harley Davidson offers a Rewards Program to the public of 3 points for every dollar spent. Lake Shore H.O.G. members receive 9 points (3 times the normal amount) for every dollar spent, along with specials that are offered throughout out the year at select events, only for chapter members.

To qualify for the aforementioned discount, it is necessary at the **time of the purchase** to tell the counter attendant that you are a current member of the Lake Shore H.O.G. chapter. In cases where identity is in

question, the counter attendant shall have the right to request to see your membership card and possibly a second form of identification.

The above aforementioned discount **does not** apply to sale items or any other special price reduction offers. Points are **not transferrable** and solely for the use of the **named chapter member**.

Lake Shore Harley Davidson reserves the right to cancel this discount program at any time. Either **individually** or in its **entirety**.

5. No Member shall at any time solicit contributions for the Chapter without the express consent and approval of the Sponsoring Dealer and the Chapter Board of Directors.

Article XV Amendments

The power to alter, amend, or repeal the by-laws or adopt new by-laws shall be vested in the Board of Directors unless otherwise provided in the articles of incorporation or the by-laws. Such action may be taken at a regular or special meeting for which written notice of the purpose shall be given. The by-laws may contain any provisions for the regulation and management of the affairs of the corporation not inconsistent with law or the articles of incorporation.
